**DR. BABURAM BHATTARAI**Former Prime Minister of Nepal

Dr. Baburam Bhattarai is the former Prime Minister of Nepal and Chairperson of the Nepal Samajwadi Party. He served as prime minister from August 2011 to March 2013. Dr. Bhattarai was the Minister of Finance (2008) and played an instrumental role in the finalization of the new constitution (2015) as Chair of the Constitutional Political Dialogue and Consensus Committee.

Dr. Bhattarai received a bachelor's degree in architecture from PunjabUniversity (1977) and a master's degree from School of Planning and Architecture, Delhi (1979). He completed his PhD in regional development planning from Jawaharlal Nehru University, New Delhi in 1986. His doctoral thesis was published in 2003 as The Nature of Underdevelopment and Regional Structure of Nepal: A Marxist Analysis. He has also contributed a number of books and articles published in English and Nepali. His areas of interest include development planning, inclusive and participatory democracy, and latest advances in science, technology and philosophy. As a visionary politician, he champions the need for radical transformation of Nepal's economy by enhancing production and stimulating economic growth alongside just distribution and sustainable green economy.



**DR. PRAKASH SHARAN MAHAT** Honorable Finance Minister of Nepal


Mr. Shah is a Tourism Expert and President of Hotel Association Nepal and Managing Director of The Airport Hotel Kathmandu.


